**WAIVER, MEDICAL CONSENT,
AND RELEASE OF LIABILITY**

PLEASE READ AND SIGN BELOW

In consideration of being allowed to participate in any way in the *Friendly Fire (Track & Field) Shoot Out™* and related events and activities, the undersigned: (1) Agrees that prior to participating they will inspect the facilities and equipment being used, and if they believe anything is unsafe, they will immediately advise appropriate meet management of such condition(s) and refuse to participate; (2) Acknowledge fully that each participant will be engaging in activities that involve risk or serious injury, including permanent disability and death, and a severe social and economic losses which might result not only from their own actions, inactions, or negligence, but the action, inactions, or negligence of others, the rules of play, or the conditions of the premises, or any equipment used. Further, that there may be other risks not known to us or not reasonably foreseeable at this time. (3) Assume all the foregoing risks and accept personal responsibility for the damages following such injury, permanent disability, or death. (4) Totally release, discharge, and covenant not to sue *Friendly Fire (Track & Field) Shoot Out™*, the ENDURO Group, LLC, the City of Lawton, host organization(s), local venue municipalities or school districts, coaches, and other employees of the organization, other participants, or volunteers hereinafter referred to as “Release” from any and all liability to the undersigned his or hers heirs, and next of kin for any and all claims, demands, losses or damages on account of injury, including death, or damage to property caused or alleged to be caused in whole or in part by the negligence of the Release or otherwise. (5) In the event that I sustain injury or illness while participating in the *Friendly Fire (Track & Field) Shoot Out™*, I hereby authorize any emergency first aid, medication, medical treatment or surgery deemed necessary by any medical personnel. I also give permission for attending medical personnel to execute on my behalf my permission forms or other necessary medical documents and to act on my behalf if I am not immediately available to do so.
